Personal data that we process

PS International processes your personal data by using our services and / or by providing it to us yourself. Below is an overview of the personal data that we can process:

- First and last name
- Address data
- Phone number
- E-mail address
- Location data
- Information about your activities on our website
- Other personal data that you actively provide, for example by creating a profile on this website, in correspondence and by telephone
- Bank account number

Special and / or sensitive personal data that we process

Our website and / or service does not intend to collect data about website visitors who are younger than 16 years. Unless they have permission from parents or guardians. However, we cannot check if a visitor is older than 16. We encourage parents to be involved in the online activities of their children, in order to prevent data about children being collected without parental consent. For what purpose and on what basis we process personal data

PS International processes your personal data for the following purposes:

- Call or e-mail if necessary to carry out our services
- inform you about changes to our services and products
- Give you the opportunity to create an account
- To deliver goods and services to you
- To analyse your behaviour on the website and thereby improve the website and tailor the range of products and services to your preferences.

Third party websites

Automated decision-making

PS International does not make decisions based on automated processing on matters that can have (significant) consequences for people. These are decisions that are taken by computer programs or systems, without involving a person (for example an employee of PS International). PS International uses the following computer programs or systems: Google Analytics, Mailchimp. We use this to improve the user experience of the website visitors.

How long we store personal data

PS International does not store your personal data longer than is strictly necessary to achieve the purposes for which your data is collected. For this we use the following storage periods per purpose:

1. Sending the newsletter and e-mailing:

Storage period: as long as necessary

You can unsubscribe yourself from the newsletter or e-mail at any time by clicking on 'unsubscribe'. You can also send an e-mail to info@onlinesportsacademy.com. Your data will be deleted immediately after deregistration.

2. Execution of the agreement:



Retention period: 7 years

We carry out inspections at every notification to prevent labour crowding. For these checks it is necessary to keep this data after the agreement. In addition, there is the legal obligation of 7 years from the tax authorities.

3. Answering quotation requests:

Storage period: 3 years

With every outgoing quotation we store simple personal details such as name, email address and telephone number of the applicant. As a result, we can make the handling proceed faster in the future.

Sharing personal data with third parties

PS International will only provide your data to third parties if this is necessary for the execution of our agreement or to comply with a legal obligation. If we provide your data to third parties for other reasons, we are obliged to ask you for permission first. With organizations that process your data, we conclude a processor agreement to ensure the same level of security and confidentiality of your data. PS International remains responsible for this processing (s).

PS International provides in any case personal data to the following parties:

Cookies, or similar techniques, that we use

A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. PS International uses only functional and analytical cookies. These are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly and remember, for example, your preferences. We can also optimize our website with this. You can opt out of cookies by setting your internet browser so that it does not store cookies anymore. In addition, you can also delete all information previously saved via the settings of your browser.

View, modify or delete data

You have the right to view, correct or delete your personal data. To ensure that the request for access has been made by you, we ask you to send a copy of your ID with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN) black in this copy.

This is to protect your privacy. We respond as quickly as possible, but within four weeks, at your request. PS International also wishes to point out that you have the opportunity to file a complaint with the national supervisory authority, the Dutch Data Protection Authority.
